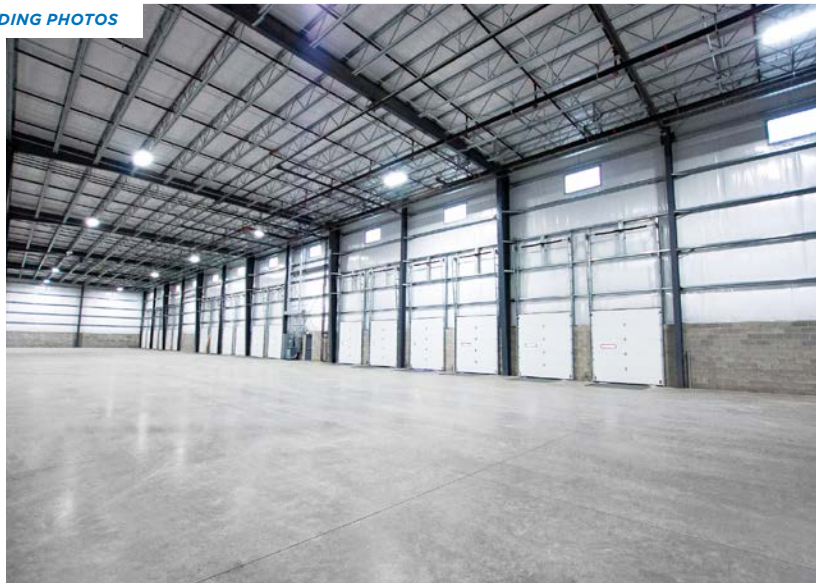

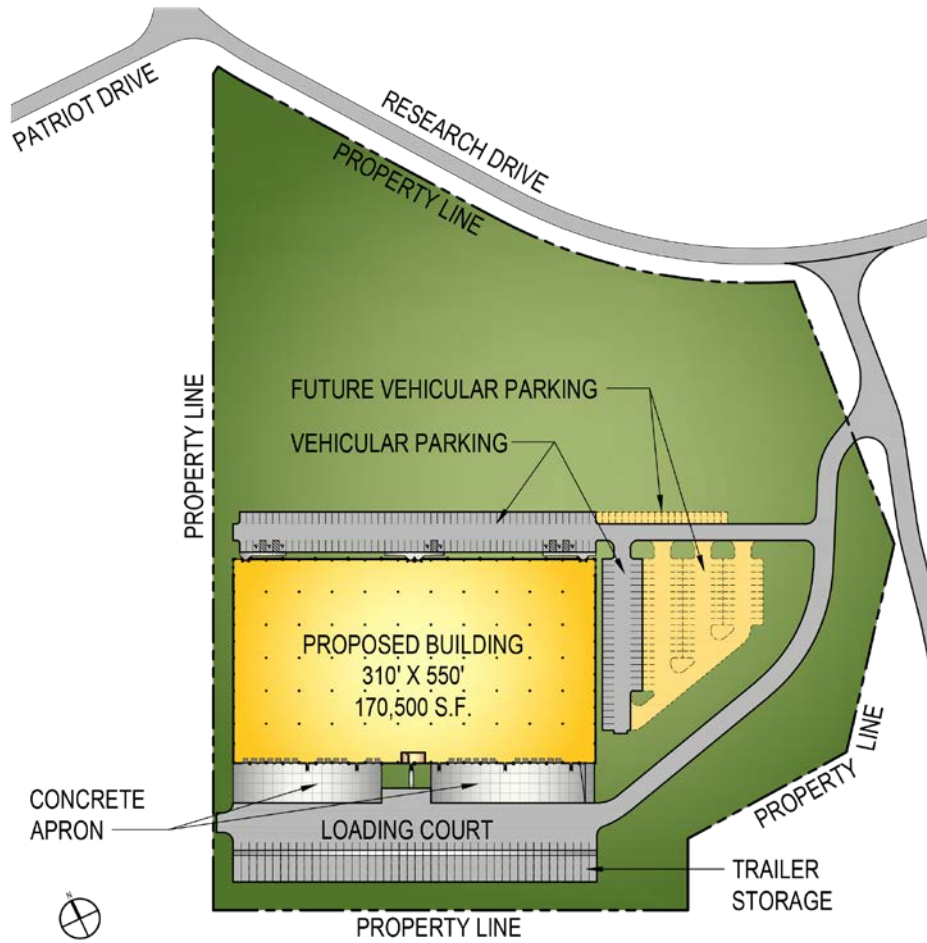

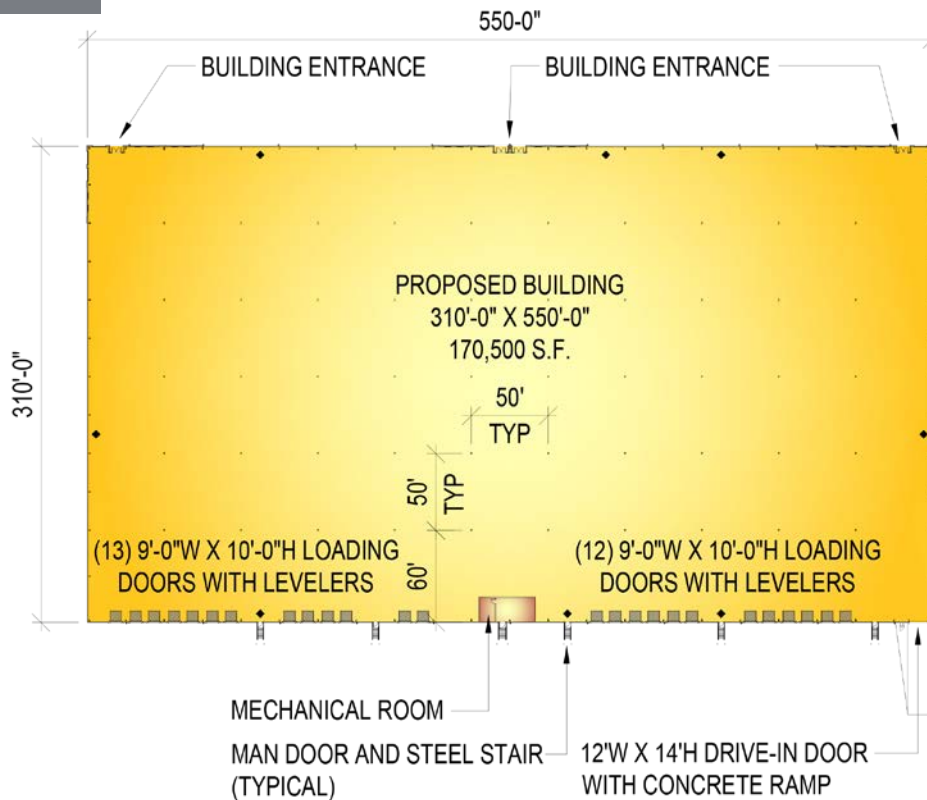

## SIZE

- ▶ **AVAILABLE SPACE:** 170,500 SF

## BUILDING CONSTRUCTION

## UTILITIES

- ▶ **WAREHOUSE HEATING:** Energy-efficient, roof mounted *Cambridge* direct-fire units.
- ▶ **WAREHOUSE LIGHTING:** Energy-efficient LED fixtures.

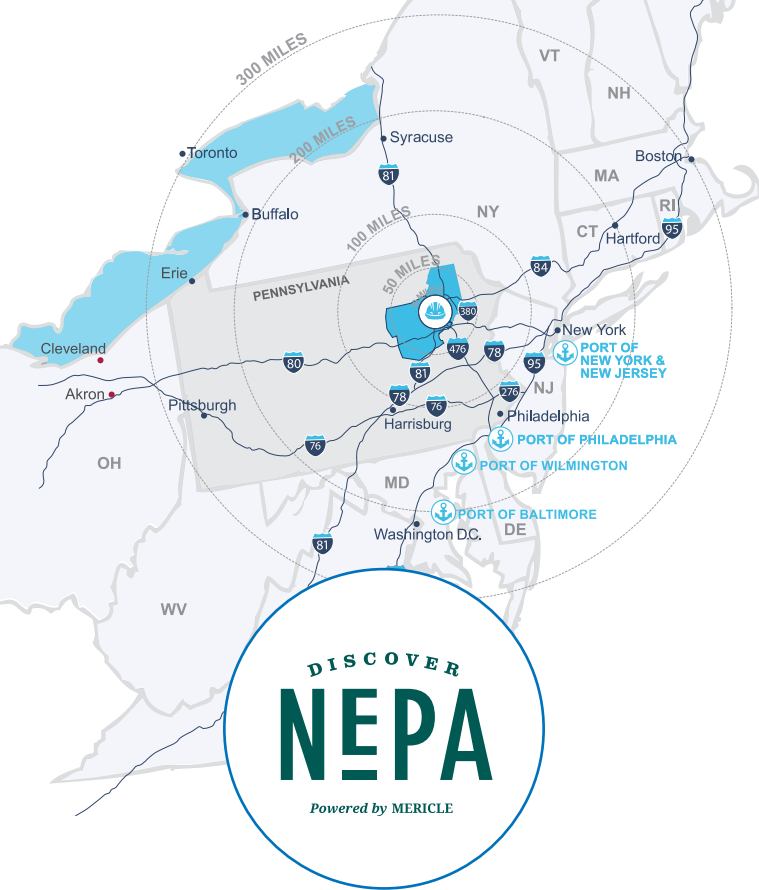

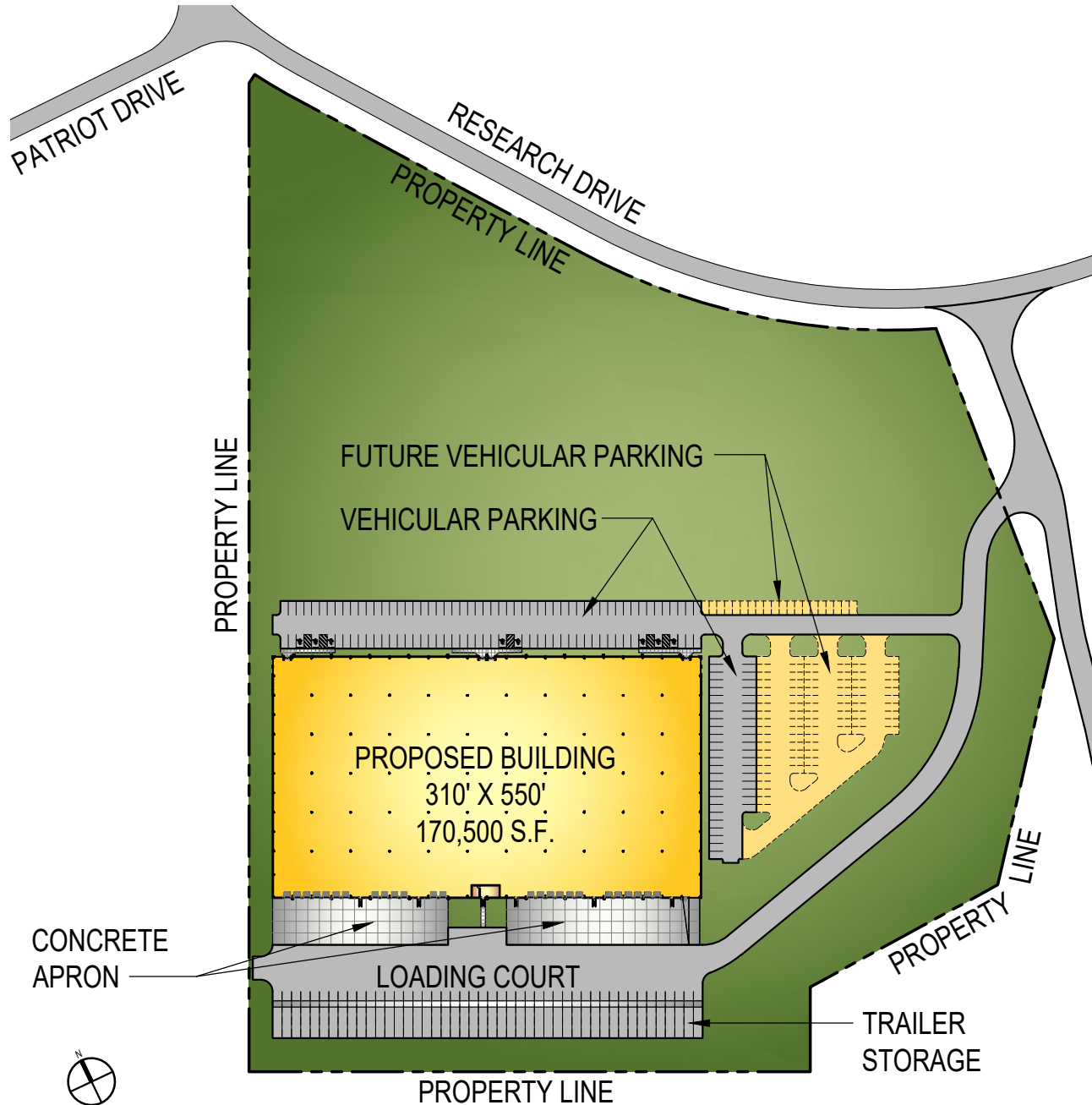

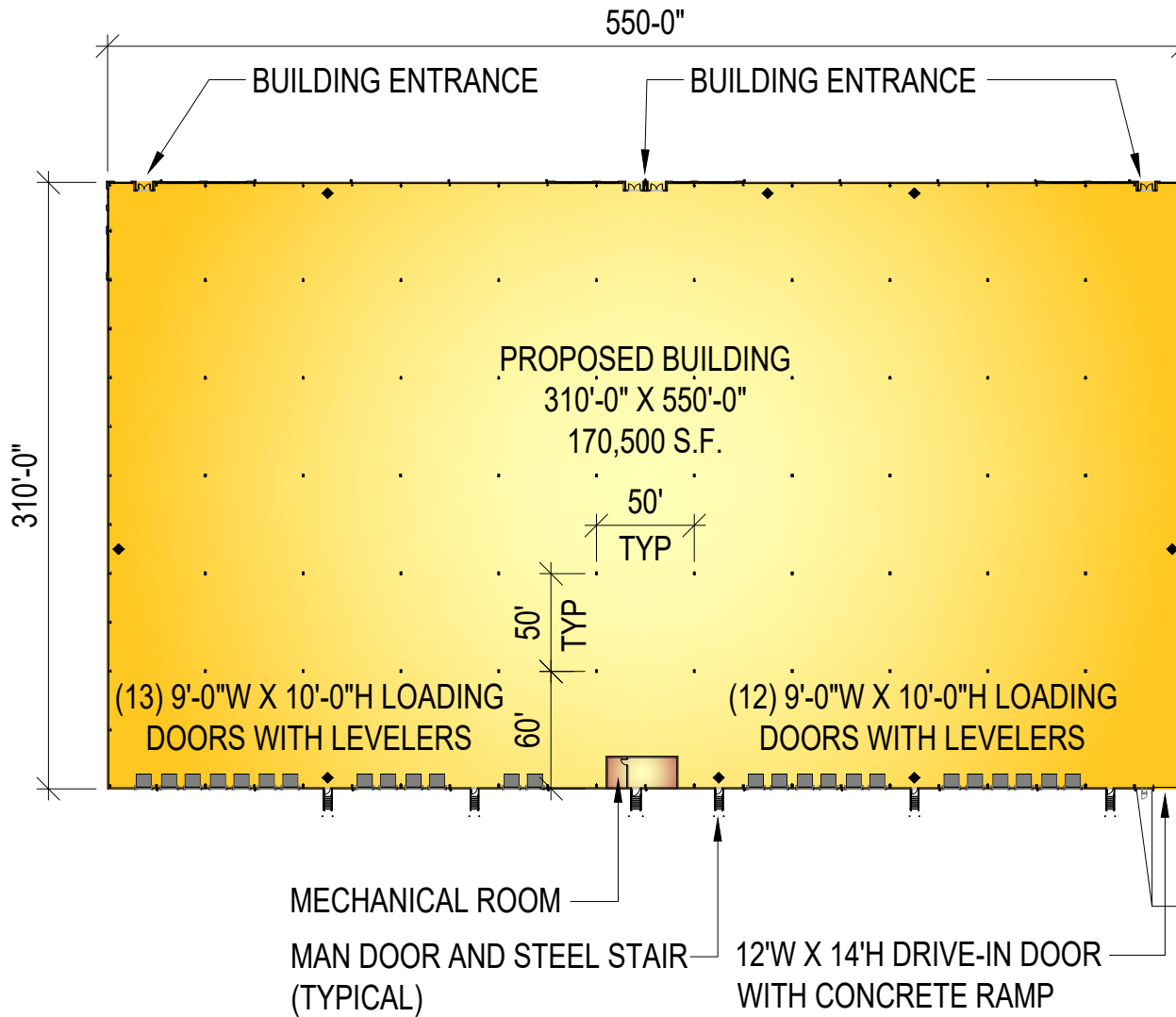
